Membership: Seven (7) members (composed of ministers and elders in numbers as nearly equal as possible).

Commissioners shall be elected for three classes, not more than one half of the members to be in one class.

No person who has served on a permanent judicial commission for a full term of six years shall be eligible for re-election until after four years have elapsed.
